Minister's Message - Rev. Joanne Hedge

My gradual return began in September, and we gathered often for worship and to celebrate the lives of community members lost during my leave. In October my hours and engagement with the church increased until the end of that month when I once again took on full-time ministry with Applewood. It was a joy to once again lead worship, create meaningful services especially through Advent and Christmas, visit with folk at Beechwood Place and Parkland on the Glen, and offer a Christmas Tea for our church family and guests. I am grateful for the work of the Worship Committee including our choir and other musicians, Affirming Committee, Outreach Committee and staff with whom I work closely, and for the support of the Admin Committee, Executive Committee, Ministry and Personnel Committee and others who help to lead and sustain our community and help me to minister here. Going forward, we need to continue to harness the energy of our volunteers while we also recognize that folk may choose, and have chosen, to retire from active volunteer work. A realistic but faithful review of all our resources – dollars, people, building, staff – may help us to make hopeful decisions in the months to come.

Paul wrote to the early church, which faced some of the same challenges that we do today: "May the God of hope fill you with such peace and joy in your faith, that you may be filled with hope by the power of the Holy Spirit." *Romans 15:13, The Inclusive Bible*

May we all be filled with that Spirit and with that hope as we continue in ministry together.

The choir also prepared several pieces for the Good Friday service and offered "The Beautiful Christ – An Easter Celebration of Grace" which inspired and moved the congregation. Thank you to the Applewood Choir for your commitment to sing and bring so much joy and meaning to the community and worship at Applewood.

Horseshoe Falls Regional Council

The Region has continued to work both virtually and in person throughout the year. The bi-monthly newsletter continues to be an important communication tool and is full of news and learning opportunities. It has kept us up-to-date on staff updates and changes. The Regional staff are always ready to assist when and where help is needed.

Workshops and webinars have continued to provide support and education for ministry personnel and lay leaders.

The Fall Meeting was held virtually and was well attended. During that meeting there were some proposals to be considered for General Council 45 which will be a hybrid meeting taking place in Calgary from August 7-11, 2025. Due to the need for further discussion, these proposals, along with some additions, were discussed and voted on at a virtual meeting in February 2025.

Rev. Lynn Allin, Minister for Congregational Support, is retiring and the position has been posted. Rev. Kevin Steeper, who was the Pastoral Support Minister, has accepted a call with the Eramosa pastoral charge.

The Spring hybrid meeting will take place on June 14th in Hamilton.

The work of the Region is always interesting and it is a wonderful opportunity to be connected to the wider church and realize that we are not alone on our journey.

Administration "Taking Care of Business"

Rentals - Applewood's total rental revenue from all sources for 2024 was \$93,401. Ongoing rentals have flourished with Appleseed Academy accounting for \$63,183, Voices Rock, Journey to Freedom & Over the Influence. Single rentals by film production companies, community organizations & private individuals continue to bolster the regular monthly income. Our primary tenant, Appleseed Academy, expanded into the Friendship Room in February 2025 providing a significant boost to income. Outlook for the coming year is very positive.

<u>Property</u> - Regular property activities in 2024 included replacing batteries, light bulbs, repairing toilets and faucets. Also, chemical flushing of the heating system and the install of automatic air breathers in the attic improved the heating overall. In addition, a 2nd sump pump was installed in the boiler room after the cleanup of the July flooding. Due to some storm water inside by the AGH windows, their exterior was caulked. In addition, the repairs to the roof were completed. Quarterly inspections of the elevator continued. Also, the annual inspection of the fire alarm system, including sensors and extinguishers.

<u>Solar Panels</u> - In 2024 the solar panels produced 12 megawatts of electricity with revenue of \$8,866 which brings the total revenue since installation in 2011 to over \$130,000.

<u>Kitchen</u> – The kitchen facilities and supplies are used by most of the congregation and Linda does a wonderful job keeping all in good order. The dishwasher and Bunn coffee system continue to be maintained on a regular basis.

<u>Archives</u> – Not much activity in the last year. Going forward files will be organized to be sent to the United Church Archives in Toronto, likely the years 2001-2015.

Members of the Admin team are to be commended for their commitment and dedication to maintaining the physical building we call "our church". Additionally, thanks should go to those who see something that needs to be done...and just do it...without fanfare and recognition. The Applewood congregation thank you all.

Board of Trustees



The Board of Trustees, Lynn Williamson, Joanne Wilson, Rev. Joanne Hedge, and Bob Martin, continue to care for the fiduciary needs of Applewood United Church.

The Insurance policy, under the UCC Protect banner, has been renewed for this year until its renewal date of December 1, 2025. Adjustments were made to take into consideration inflationary factors, with an approximately

5% increase in premiums from last year. The increase in premium was much less than in prior years, as the United Church is self-insuring for smaller losses.

The Visioning Reserve continues to be depleted and will run out of money by the end of this year. However, over the years, the reserve has provided funding for part-time staff, and several other small programs the church runs.

Going forward, in its place, the Manse Reserve Fund will take over where the Visioning Reserve leaves off, providing a seamless transfer of funding for ongoing programs and projects. Interest rates are on the decline for our invested GIC's, but over the past three years or so, we have had a good return. Interest rates are not controlled by us, but we are ever vigilant in earning the best rate possible on GIC renewals, keeping in mind the CDIC maximum of \$100,000 per investment.

In the past few years, the Board of Trustees has set up a reserve for the Capital Fund. Members of the congregation are contributing to it on a regular basis. The fund now sits at \$42,662.98. This money will be used as the need arises for capital improvements to the building. Although some have misnamed this fund "the roof fund", the money can be allocated for any capital improvements deemed necessary by the Executive Committee.

Our Treasurer, Lori Coleman, had some excess funds in our Operating Bank Account which was not earning interest. She transferred the money to the Board of Trustees who are investing the money until needed. The Segregated Funds (from Operating Account) has a balance of \$54,455.97. At any time, Lori can request that the Trustees transfer any or all these funds to the Operating Account, according to need for such funds.

As of the end of December, The Board of Trustees oversaw over \$617,000. of fund assets. There are a number of funds that have specific terms of reference, but there are others that do not. If any group has a project for which they need funding, they need only send an email, or letter, to the Board of Trustees for consideration. It is in the best interests of the church to use the funds, rather than have them sit dormant.

Bob Martin, Senior Trustee, has advised the Executive Committee that he will be retiring December 31, 2026. It would be in the best interest of Applewood United Church to provide a replacement, preferably sooner than later, so that the person replacing Bob will have a chance to "shadow" him for at least a year prior to retirement.

Affirming Committee



The Affirming Committee has been busy throughout the year. Here are some of the highlights.

In June we were invited to be part of Sheridan College's Pride Event. Our table attracted many students and we were able to talk about the work we do and the safe space we offer for events. We also attended the raising of the Pride Flag at City Hall and at Peel Police Headquarters.

In July we were present at the Rainbow Sauga Alliance BBQ at the Unitarian Church. This was a great event with entertainment, presentations and information sharing.

In September some members of the committee joined a march in support of Grassy Narrows as they continue to bring attention to the mercury poisoning which has affected their community for so long.

In October we were invited to attend the Rainbow Sauga Alliance Mix and Mingle evening. It was a wonderful opportunity to meet and network with that group and also other allies. The relationship continues to develop.

November saw us hosting the first of two workshops focusing on our theme of Allyship in Action. This topic was on the issues which currently face the 2SLGBTQ+ community and how we, as allies (accomplices) can provide support.

Several committee members were invited by East Mississauga Community Health Centre to attend an Indigenous Network evening where awards were presented to community organizations for their support throughout the year.

We again hosted a group from East Mississauga Community Health Centre for their Christmas dinner at Applewood. The committee provided dinner and hosted the group who were very appreciative of the safe space to celebrate.

In February some committee members attended a Peel Police Presentation on Countering Hate which was very informative in identifying what hate crimes are, how under-reported they are, as well as how they are followed up.

In March we hosted PIE Sunday when we sold pieces of pie to raise money which was donated to Glad Day Bookshop in Toronto. The second of our workshops was held at the end of the month, this time focusing particularly on seniors. We collected 28 signatures on Kairos Canada's Turn Debt Into Hope campaign petition.

On May 4th Applewood celebrated our 11th anniversary of becoming Affirming. Tom Lebour and Ron Cameron-Lewis from Rainbow Sauga Alliance were our guest speakers. We continue to hear that the work we do is very much appreciated in the wider community.

During the year we highlight news articles in the AppleLog to help us stay informed about what is happening in our community, across Canada, and around the world. We also highlight the special days of remembrance and celebration each month. We have shared information with our

congregation about various workshops and/or issues, including the ongoing wars on both Gaza and Ukraine.

Thank you to the committee for all the hard work they have done this year. The members are: Sophie Cook, Christina Miller, Peggy Grozelle and Brian McIntosh.

ACCOUNTS

NOTES TO SPECIFIC ENTRIES

The cash assets of the pastoral charge are held in three bank accounts – the
account for general funds through which most of the transactions occur and the two
account for the Trustees where the financial assets under the authority of the
Trustees Committee are held.

In addition, when specifically designated funds pass through the General Funds account for accounting purposes but are not to be disbursed immediately (although usually committed to a specific purpose), they are designated as "segregated funds" so as not to confuse the monies with normal operating income and have it reflect incorrectly in current operating results. The process also serves to eliminate the need for individual groups to maintain bank accounts of their own when small amounts and/or temporary situations are involved (maintaining separate bank accounts in any event requires special approval of the Executive Committee). The various segregated funds include those associated with the operation of the congregation (see Schedule 3) and those held in trust on behalf of the Trustees (see Schedule 2)

As of July 2022 these funds have moved to Trustees for investing until funds required. Excess funds received will continue to be transferred in order to earn Interest.

The accumulated surplus includes all funds and accounts and is comprised as follows:

- 2. Valuations were placed on the Church Building property in 1978 when a revised format for Revenue Canada reporting was instituted. Since that time all capital outlays for building improvements and/or equipment and new furnishings have been charged directly to operating expenses during the year in which such expenditures were made. For accounting purposes the statement valuations on fixed assets therefore remain constant and do not pretend to reflect current market values. The property was assessed in 2019 by Vericost Property Appraisal Services to ensure adequate insurance coverage.
- 3. A grant received in 2007 from Hamilton Conference for Vision projects was placed in funds administered by the Trustees (Schedule 2). Interest earned on investments was transferred to the general account for operating expenses in the amount of \$1,278.72. Revenue from the solar panels is shared between operating and repayment to Vision for the initial installation expenditure funded in 2011. To date the revenue earned totals \$131,047.03. The Vision committee decision to share is made each year during budget planning. In addition \$15,977.48 was transferred from the principal to fund our community visitor role.

4. Supporting the wider United Church of Canada efforts through Mission and Service (M&S) continues to be well supported by Applewood United contributors. In 2024 \$56,154 was contributed to M&S. Much of the monies are used to support initiatives across Canada. Certain funds, donated for community charity, were included in receipts issued for charitable donations or were raised through special projects and were forwarded to the parties designated as follows:

5. In June of 2015 a bequest in the amount of \$924,546.30 was made on behalf of the estate of Ann Graham and is placed under the care of the Trustees to invest and disburse based on Ann's wishes. (Schedule 2) As with all Trust funds, the interest earned on the principal is transferred to the operating account on an annual basis. A committee to oversee the Ann Graham Memorial Fund (AGMF) was created. The bulk of monies have been used to renovate the kitchen and hall which was completed in 2019. The hall was renamed in honour of Ann with her family present.

One disbursement was made in 2022 relating to the memorial garden that was impacted during the renovation.

- 6. Applewood United raises funds through renting space at our church on a short term basis along with leasing space to Appleseed Academy of Early Learning, Voices Rock, Over the Influence, Journey to Freedom and Girl Guides. Additionally one film production rented space this year. This resulted in revenue in the amount of \$93,401. In late 2021 Appleseed had been granted additional space and the rent was increased to reflect usage.
- 7. In response to our community needs a benevolent fund was created in 2023 along with a small pantry which is replenished as required. To date \$7,059 has been raised and this continues with members of our congregation donating on the first Sunday of each month.
